Professional Licensure Disclosures

The Clinical Science program at Virginia Tech (VT) makes every effort to ensure state licensure or certification information is current; however, state requirements may change. If you are planning to pursue professional licensure or certification in the future, it is strongly recommended that you contact the appropriate licensing entity in that state to seek information and guidance regarding licensure or certification requirements before beginning an academic program.

The doctoral program in Clinical Science at VT is accredited by the APA (American Psychological Association) and PCSAS (Psychological Clinical Science Accreditation System). APA accreditation is recognized in all 50 states as providing required education for psychology license eligibility. State Boards of Psychology determine training requirements for licensure and typically include post-doctoral training as well as examinations beyond the educational requirements, so a doctoral degree from VT in Clinical Science is not sufficient to meet licensure requirements in most states. Students should confirm state licensing requirements directly with the state they are interested in licensure. ASPPB (Association of State and Provincial Psychology Boards) provides a compendium called PsyBook at http://psybook.asppb.org/ which summarizes requirements for most states, and may be a helpful resource for students determining vocational location and licensing requirements. As an update, the ASPPB has added information about state licensing requirements on their website. It can be located here, under consumer information disclosures: https://asppbcentre.org/additional-resources/survey-questions-and-answers/, but the last update as of this writing appears to be July 15, 2021. Eventually, this information will be updated annually on the PSY/Book site. In the meantime, this link might be useful if you are interested in looking up states where you might wish to be licensed.

Generally, the way licensure works in clinical psychology, is (1) complete an approved education program. APA accredited programs are recognized in all states, although some states impose additional education and training requirements; (2) complete an APPIC (Association of Psychology and Postdoctoral Internship Centers) accredited full-time one year internship—internship is a requirement for the degree if you are in an APA accredited program such as VT's, and APPIC coordinates a nationwide internship match for students each year; (3) complete a 1 year post-doctoral fellowship with supervised clinical experience under the appropriate license or registration for the state you are located in (some states do not require a post-doc); (4) take the national (EPPP—Examination for Professional Practice in Psychology) and state examinations required; (5) complete any additional requirements for the state you are seeking licensure in (typically background checks and credential verifications, but some states have some specific training requirements as well).

VT's Clinical Science program produces graduates who are successfully licensed as psychologists in many states. To our knowledge, no VT graduate has been turned down for psychology licensure due to insufficiencies in the education and training our program provides, but as noted above some states do have additional training and education requirements and most states have post-doctoral clinical supervision requirements as well.

Below is a state-by-state listing of our recent understanding of educational requirements, based largely on the annual review by ASPPB, to give you a general idea of how well VT fits with the educational requirements of

each state (i.e., satisfying #1 above: completing an approved education program). You should directly check the web sites of the State Licensing Board you are interested in for the most accurate and up to date information on educational and other requirements for licensure as there is no guarantee that our summary or ASPPB's is entirely accurate and up to date.

Note that the requirement for Consumer Information Disclosures comes from the U.S. Department of Education, so this document only includes state-by-state requirements for licensure. The Canadian psychology regulatory community has agreed that a doctoral degree earned in a program accredited by the Canadian Psychological Association (or the American Psychological Association) is the standard acceptable for registration as a Psychologist. Canadian provinces and territories are all in the process of moving to that standard.

Specifically, CA licensure requires additional coursework or training experiences in 1) human sexuality, 2) child abuse assessment, 3) spousal/partner abuse assessment, detection and intervention strategies, 4) aging and long-term care, 5) alcohol/chemical substance dependency detection and treatment, and 6) suicide risk assessment and intervention.

Specifically, Michigan requires additional training in identifying victims of human trafficking before being approved for licensure. See Michigan admin <u>code R.338-2525</u> for several possibilities that meet this requirement ranging from reading an article to taking a continuing education workshop.
